

## Rules for the Prize Contest

### "Birthday Giveaway – Vitamin Boost & Spa Treatment"

#### **ARTICLE 1: ORGANIZER**

The prize contest is organized and conducted by Žito d.d., hotel Materra, Đakovština 3, 31 000 Osijek, Croatia, [www.zito.hr](http://www.zito.hr), OIB: 03834418154 (hereinafter referred to as the "Organizer"). The contest is not associated with, sponsored, or promoted by any social media platforms mentioned in these rules.

#### **ARTICLE 2: DURATION, PURPOSE, AND LOCATION OF THE CONTEST**

The prize contest is conducted to promote the Organizer's products and services. It runs from February 23, 2025, at 10:30 PM until February 26, 2025, at 12:00 PM.

#### **ARTICLE 3: PRIZE FUND DETERMINED BY THE ORGANIZER**

#### **ARTICLE 4: ELIGIBILITY**

All natural persons are eligible to participate in the contest, except for employees of the Organizer.

#### **ARTICLE 5: HOW TO PARTICIPATE, WINNER SELECTION, ANNOUNCEMENT, AND PRIZE DELIVERY**

Users must tag one or more people in a comment under the contest post to enter. All participants who meet the contest requirements will enter the final selection, and the winner will be publicly announced on February 26, 2025, at 2:00 PM. The winners will be selected through a random draw using the online tool Comment Picker. The awarded prize must be used within 90 days. Winners will be notified via the HOTEL MATERRA Facebook and

Instagram pages through comments under the contest post and Stories. The prize delivery will be arranged via direct messages on social media. Winners must respond within 24 hours of the contest's conclusion to provide the necessary personal details for prize delivery.

#### **ARTICLE 6: CONTEST PARTICIPANTS**

Participants cannot request more prizes than those specified in these rules, nor can they request alternative prizes. By entering, participants agree to these rules. No purchase is required to participate.

#### **ARTICLE 7: ERRORS AND INVALID ENTRIES**

Entries that are incorrect or incomplete will be invalid and ineligible for a prize. According to Instagram and Facebook rules, only profiles where the username matches the participant's actual name (as shown on an ID) are considered valid. If the name submitted differs from the one on the profile, the participant will be disqualified.

#### **ARTICLE 8: UNDERAGE PARTICIPANTS**

Minors can participate in the contest by legal regulations. If a minor wins, the prize will be awarded to their legal guardian or representative upon parental or guardianship status verification.

#### **ARTICLE 9: USE OF PERSONAL DATA**

By participating in the contest, entrants agree to these rules and authorize the Organizer to collect and process the personal data of the winners (contact details on Instagram and Facebook, full name, address, email, phone number) to conduct the contest.

The Organizer will take all necessary measures to ensure the safe handling of personal data by applicable regulations and the General Data Protection Regulation (GDPR). Participants can access, update, delete their data, object to processing, and withdraw consent. The Organizer commits not to share personal data with third parties. By participating, entrants agree that their contest submission may be shared on the HOTEL MATERRA Instagram and Facebook pages.

#### **ARTICLE 10: DISPUTE RESOLUTION**

In case of a dispute between the Organizer and a contest participant, the Municipal Court in Osijek shall have jurisdiction.

#### **ARTICLE 11: POSSIBILITY OF CONTEST TERMINATION**

The contest may be terminated only in circumstances beyond the Organizer's control, which could not have been prevented, resolved, or avoided. In such a case, the Organizer is released

from obligations toward participants. Contestants will be notified of cancellation via the official Instagram and Facebook pages.

**ARTICLE 12: PUBLICATION OF RULES**

The contest rules will be published on the Organizer's website and included in the contest post as an online link.
