

Rules for the "Birthday Giveaway" Contest - Dinner for two at the hotel's restaurant

Article 1: ORGANIZER

The contest is organized by Žito d.d., Hotel Materra, Đakovština 3, 31 000 Osijek, Croatia, www.zito.hr, VAT number: 03834418154, hereinafter referred to as the Organizer. This contest is not connected, sponsored, or promoted by the social media platforms mentioned in these rules.

Article 2: DURATION, PURPOSE, AND LOCATION OF THE CONTEST

The contest is conducted to promote the Organizer's products and services. The contest will run from noon on February 16, 2025, until noon on February 19, 2025.

Article 3: PRIZE FUND DETERMINED BY THE ORGANIZER

Prize: One dinner for two people at the Materra Hotel restaurant will be awarded on the HOTEL MATERRA Facebook page, and one dinnert for two people at the hotel restaurant will be awarded on the HOTEL MATERRA Instagram page.

Article 4: RIGHT TO PARTICIPATE

Participation is open to all individuals excluding employees of the Organizer's company.

Article 5: HOW TO PARTICIPATE IN THE CONTEST, SELECTION OF WINNERS, ANNOUNCEMENT OF WINNERS, AND PRIZE DELIVERY

To enter the contest, all users must tag one or more people in the comments under the post. Those who meet the contest requirements will be included in the final selection, and the winner will be publicly announced on February 19, 2025, at 2:00 PM. The winner will be selected randomly using an appropriate online tool (<https://commentpicker.com>). The prize must be used within 60 days.

Winners will be notified on HOTEL MATERRA's Facebook and Instagram pages through comments in the contest posts and stories. The prize delivery will be arranged via private messages on social media. Winners must respond within 24 hours of the contest's conclusion to provide personal details needed for prize delivery.

Article 6: CONTEST PARTICIPANTS

Participants in the contest cannot claim prizes in larger quantities or prizes different from those specified in the Rules by the Organizer. By participating in this contest, participants accept these Rules. No purchase obligation is required to participate in the competition.

Article 7: ERRORS AND INVALID ENTRIES

Incorrect or incomplete participation entries are invalid and do not entitle the participant to any prize. According to the rules of Instagram and Facebook, valid profiles are only those whose profile name matches the participant's actual name (as stated on their ID). If the name

provided during entry differs from the name on the profile, the profile owner is not eligible to participate in the contest.

Article 8: MINOR PARTICIPANTS

In accordance with the law, minors are eligible to participate in the contest. If a minor wins the prize, the Organizer will deliver it to the person legally responsible for the minor after verifying documents that prove the parental or guardian relationship.

Article 9: USE OF PERSONAL DATA

By participating in the contest, the participant accepts these Rules and authorizes the Organizer to collect and process personal data (contact details on Instagram and Facebook, name, surname, address, email, phone number, and/or mobile number) to conduct the contest. The Organizer will take all reasonably necessary measures to ensure that the participant's data is processed and used securely and according to applicable laws and the General Data Protection Regulation (GDPR). During data management, the participant has the right to access, update, or delete their data from the database, the right to object, and the right to withdraw consent. The Organizer commits not to share or transfer personal data to third parties. By participating in the contest, the participant agrees that their entry may be shared on the HOTEL MATERRA Instagram and Facebook pages.

Article 10: IN CASE OF DISPUTE

In a dispute between the Organizer and a participant, the competent court is the Municipal Court in Osijek.

Article 11: POSSIBILITY OF CANCELLING THE CONTEST

The contest may be canceled only in circumstances that the Organizer is not responsible for and could not have prevented or avoided. In such a case, the Organizer will be relieved of any obligations towards the participants. Participants will be notified of the contest cancellation via the official Instagram and Facebook pages.

Article 12: PUBLICATION OF RULES

The contest rules will be published on the website and highlighted in the contest post as an online link.
