

Giveaway Rules

“Giveaway”

Article 1: ORGANIZER

The prize giveaway is organized and conducted by: Žito d.d., Hotel Materra, Đakovština 3, 31 000 Osijek, Croatia, www.zito.hr, VAT ID (OIB): 03834418154, hereinafter referred to as the Organizer.

This giveaway is in no way associated with, sponsored, or promoted by the social media platforms mentioned in these rules.

Article 2: DURATION, PURPOSE AND LOCATION OF THE GIVEAWAY

The giveaway is organized for the purpose of promoting the Organizer’s products and services.

The giveaway runs from February 9, 2026 at 8:00 PM until February 12, 2026 at 12:00 PM.

Article 3: PRIZE FUND DETERMINED BY THE ORGANIZER

Prize:

1x overnight stay for two persons at Hotel Materra will be awarded on the HOTEL MATERRA Facebook page, and

1x overnight stay for two persons at Hotel Materra will be awarded on the HOTEL MATERRA Instagram page.

Article 4: ELIGIBILITY

All natural persons are eligible to participate, except employees of the Organizer.

Article 5: HOW TO PARTICIPATE, WINNER SELECTION, ANNOUNCEMENT AND PRIZE DELIVERY

All users who tag one or more persons in the comments under the giveaway post will enter the prize draw.

All participants who meet the giveaway conditions will be included in the final selection, and the winner will be publicly announced on February 12, 2026 at 2:00 PM.

Winners will be selected randomly using an appropriate website (<https://commentpicker.com>).

The awarded prize must be used by June 30, 2026.

Winners will be notified on the HOTEL MATERRA Facebook and Instagram pages via a comment under the giveaway post and via Story. Prize delivery details will be arranged through direct messages on social media.

Winners must respond within 24 hours after the end of the giveaway to provide the Organizer with the personal data necessary for prize delivery.

Article 6: PARTICIPANTS

Participants may not request prizes in greater quantities or different prizes than those specified in these Rules.

By participating, participants accept these Rules.

The giveaway does not impose any purchase obligation as a condition of participation.

Article 7: ERRORS AND INVALID ENTRIES

Incorrect or incomplete entries are invalid and do not entitle participants to any prize. In accordance with Instagram and Facebook rules, valid profiles are only those where the profile name corresponds to the participant's real first and last name (as stated on their ID card). If the name provided during data submission differs from the name on the profile, the participant will not be eligible to participate.

Article 8: MINORS

Minors have the right to participate in accordance with applicable law. If a minor wins the prize, the Organizer will award the prize to the person legally responsible for the minor, upon presentation of documentation proving parental or guardianship status.

Article 9: USE OF PERSONAL DATA

By participating, participants confirm their acceptance of these Rules and authorize the Organizer to collect and process the winner's personal data (Instagram and Facebook contact details, full name, address, email, telephone and/or mobile number) for the purpose of conducting the giveaway.

The Organizer will take all reasonably necessary measures to ensure that personal data is processed securely and in accordance with applicable legislation and the General Data Protection Regulation (GDPR).

Participants have the right to access, update, delete their data, object to processing, and withdraw consent.

The Organizer undertakes not to transfer or disclose personal data to third parties.

By participating, participants agree that their entry may be shared on the HOTEL MATERRA Instagram and Facebook pages.

Article 10: DISPUTES

In the event of a dispute between the Organizer and participants, the Municipal Court in Osijek shall have jurisdiction.

Article 11: TERMINATION OF THE GIVEAWAY

The giveaway may only be terminated in the event of circumstances beyond the Organizer's control which could not have been prevented, eliminated, or avoided. In such a case, the Organizer shall be released from any obligations toward participants.

Participants will be informed of any termination via the official Instagram and Facebook pages.

Article 12: PUBLICATION OF RULES

The giveaway rules will be published on the website and referenced in the giveaway post in the form of an online link.
